The Municipal Utility Board met in a Regular Session at 6:00 p.m. on Monday, March 1, 2021, with Chairman Harris presiding. The agenda was posted in the outside Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Dr. Ken Rains, Ms. Lorri Mitchell, Mr. Mark Roberts, and Dr. Art Sixkiller.

Guests attending from Grand River Dam Authority were Mr. Jerry Cook and Mr. Mason Mulry.

A motion was made by Dr. Rains and seconded by Mr. Roberts to approve the minutes of the Regular Meeting held February 16, 2021. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Roberts, Mitchell, Sixkiller, and Harris Nay – none

A motion was made by Dr. Sixkiller and seconded by Ms. Mitchell to approve Claims #871 - #920 totaling \$323,113.35 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Mitchell, Rains, Roberts, and Harris Nay – none

The Board recognized Mr. Jerry Cook, who expressed customer appreciation on behalf of Grand River Dam Authority to Mr. Jared Crisp and members of the Municipal Utility Board. Mr. Cook discussed the affiliation of the Southwestern Power Pool and Grand River Dam Authority and recommended the Board view a 10-12 minute segment of the February 26, 2021 Oklahoma News Report discussing the "Challenges facing energy producers and their customers following last week's freeze". Mr. Cook will share the link with Mr. Crisp who will forward the link to the Board Members.

The Board recognized Mr. Crisp who discussed a slide presentation of proposed water projects for two separate business developments on South Mill Street. The first presentation was between Park and SE 6th Street and the second presentation was on the Westside of the railroad tracks at SE 49th Street. Mr. Crisp also discussed a possible easement to allow an upgrade to the natural gas main from the City Gate into town and a new lift station to tie into the existing force-main that feeds the Treatment Plant to the property of the new development on SE 49th Street.

Mr. Crisp reported the City of Pryor Creek provided \$35,952.69 for reimbursement of paid COVID-19 sick leave during the 2020 pandemic.

Mr. Crisp reported the easements necessary to complete Phase I of the East Salt Branch Sanitary Sewer Extension on North 69 Highway have been filed with the Mayes County Clerk's Office.

Mr. Crisp reported he had been attending the interviews for a Natural Gas Mechanic and a Wastewater Treatment Plant Operator.

Mr. Crisp reported the Contractor (Mibb Construction Inc.) has been scheduled to begin improvements to the equipment shed at the warehouse.

Mr. Crisp reported he had been in discussion with BlueMark Energy, LLC and Grand River Dam Authority regarding the enormous natural gas spot market price during the cold blast and its effect to our invoices and fuel cost adjustments.

Mr. Crisp reported the new building plans for Kum & Go, Bank of Commerce, and RCB Bank had been reviewed. He also reported the utility services were secured for the demolition of the old Homeland (506 E Graham Avenue).

The Board recognized Mr. Steve Powell who reported he had been visiting with three of the four property owners regarding easements for an electric system extension on Damon Drive and East Fairland Street. Mr. Crisp added he had visited with the fourth property owner regarding an easement and was waiting for his reply.

Mr. Powell reported the model was running for the MUB Water System Study and he would be reviewing the data with staff before preparing his presentation to the Board.

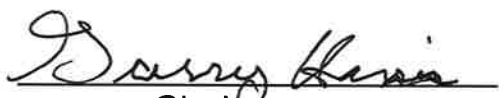
The Board recognized Mrs. Teri Hill who had no report.
