



May 3, 2021

The Municipal Utility Board met in a Regular Session at 6:00 p.m. on Monday, May 3, 2021, with Chairman Harris presiding. The agenda was posted in the outside Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Dr. Ken Rains, Mr. Mark Roberts, Ms. Lorri Mitchell, and Dr. Art Sixkiller.

Guests attending were Mr. Travis Willis and Mr. Terry Aylward.

Mr. Jared Crisp reported Wesco-Diversified quoted an incorrect item on Line Item #1 of Bid #931 (Electric Material) so Line Item #1 of Bid #931 was awarded to the next lowest bidder, Arkansas Electric, for an increase of \$129.60 which changed the total to \$47,610.55 for Bid #931 (Electric Material).

A motion was made by Dr. Sixkiller and seconded by Ms. Mitchell to award Line Item #1 of Bid #931 (Electric Material) to the next lowest bidder, Arkansas Electric, for an increase of \$129.60 which changed the total to \$47,610.55 for Bid #931 (Electric Material) then approve the minutes of the Regular Meeting held April 19, 2021. A motion was made by Dr. Sixkiller and seconded by Dr. Rains to approve Claims #1150 - #1200 totaling \$326,260.22 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Rains, Roberts, Mitchell, and Harris Nay – none

The Board recognized the Honorable Mayor Lees who was encouraged by tours he hosted for small industry and land developers interested in city utility services. He also reported on the positive partnerships the City of Pryor Creek has with the Mid-America Industrial Park and the Main Street beautification projects.

The Board recognized Mr. Steve Powell who reported he would review the response to the anticipated Notice of Violation at the Wastewater Treatment Plant with Mr. Crisp and Mr. Chuck Bley this week. He also updated the Board on the installation of the interconnect relay by Mr. R. W. Vaught which should correct the cause of the violation.

Mr. Powell reported the construction of the Proposed Sanitary Sewer Interceptor Extension (Giles Sewer) kicked off on May 3, 2021. He also reported a correction was completed on the final easement on this project and delivered it to Mr. and Mrs. Ray Sherman who should return it to the Municipal Utility Board Business Office on May 4, 2021.

Mr. Powell discussed the Model of our Water System Improvements Hydraulic Analysis and his request for MUB Staff to perform PSI samples at ten (10) designated sites and three (3) designated fire hydrants for comparison to the Model before his report and recommendations are presented to the Board.

The Board recognized Mr. Jared Crisp who reported Ms. Lorrie Mitchell and Dr. Ken Rains served on the Fiscal Year Ending June 30, 2021 Budget Committee with Dr. Art Sixkiller as an alternate. Mr. Crisp requested the current Budget Committee continue to serve with no changes on the Fiscal Year Ending June 30, 2022 Budget Committee. There was no discussion or objection to his request.

Mr. Crisp presented a color brochure which announced "The District Grand Opening Summer 2021".

Mr. Crisp shared a visual presentation of a before and after repair of a busted sewer line at a sewer manhole located west of Dog Pound Road near the old Wastewater Treatment Plant in the flood plain. The busted sewer line caused the Wastewater Treatment Plant to unnecessarily treat rain water. The sewer department will continue to walk and inspect the main sewer lines in the flood plain.

The Board recognized Mrs. Teri Hill who had no report.

A written Department Foreman's Report was presented with no additional comments.

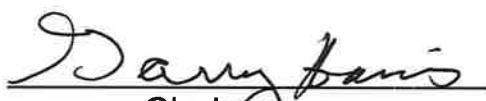

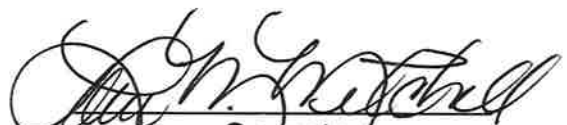
