



July 6, 2020

The Municipal Utility Board met in a Regular Session at 6:00 o'clock p.m. on Monday, 6 July 2020, with Chairman Harris presiding. The agenda was posted in the outside Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Dr. Ken Rains, Ms. Lorri Mitchell, Mr. Mark Roberts, and Dr. Art Sixkiller.

A motion was made by Dr. Rains and seconded by Mr. Roberts to approve the minutes of the Regular Meeting held June 30, 2020 as presented. MOTION CARRIED. Votes cast as follows: Ayes – Harris, Roberts, Rains, and Sixkiller. Abstaining (counting as a no vote): Mitchell.

Mr. Crisp discussed the Claims and Contracts Pending list ending 6 July 2020 totaling \$739,524.96.

A motion was made by Mr. Roberts and seconded by Dr. Rains to approve Claims #0001 - #0017 totaling \$739,524.96 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Mitchell, Sixkiller, Harris, and Roberts. Nay – none

Mr. Harris recognized Mayor Larry Lees. Mayor Lees discussed the water rate increase request had been placed on the Council Meeting agenda to be presented July 7, 2020 for approval. He also stated there were positive COVID-19 cases in the Fire and Police departments and he would be encouraging the use of masks and to continue social distancing practices.

Mr. Crisp gave the Engineer's Report. He stated Mr. Powell has been working on cost estimates for the lift station upgrades. He also discussed that Lead/Copper water samples will be taken at 20 sites throughout the system for testing. The Lead/Copper testing must be done every three (3) years. Lastly, he reported a property owner has slowed the North Sewer Extension Project. An assessment has been ordered to determine the property value before any action is taken.

Mr. Crisp gave the Manager's Report. He revisited the current statistics regarding COVID-19. He also gave the Board an expense status, tracked by department, for materials, labor and equipment for The District.

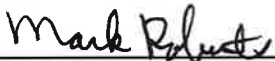
Mr. Harris recognized Mrs. Hannah Moore, who had no report.
