



December 7, 2020

The Municipal Utility Board met in a Regular Session at 6:00 p.m. on Monday, December 7, 2020, with Chairman Harris presiding. The agenda was posted in the outside Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Dr. Ken Rains, Ms. Lorri Mitchell, Mr. Mark Roberts and Dr. Art Sixkiller.

A motion was made by Dr. Rains and seconded by Mr. Roberts to approve the minutes of the Regular Meeting held November 16, 2020. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Rains, Mitchell, Roberts, and Harris Nay – none

A motion was made by Dr. Sixkiller and seconded by Ms. Mitchell to approve Claims #542 - #615 totaling \$754,413.13 for payment. MOTION CARRIED. Votes cast as follows: Ayes –Sixkiller, Mitchell, Rains, Roberts, and Harris Nay – none

The Board recognized the Honorable Mayor Larry Lees who reported on several projects. He also reported at the next city council meeting there would be discussion of a possible mask ordinance and stated to present any questions, comments or concerns we have with our city councilor(s) in our respective wards.

The Board recognized Mr. Steve Powell (*attending by Video Conference*) updated the Board on the Wastewater Treatment Plant Study.

Mr. Powell reported on the 9th Street Lift Station Phase I plans schedule that includes having plans completed for staff to review by the end of the week.

Mr. Powell reported on the 14th Street and Fairland Street Project.

Mr. Powell reported on providing cost estimates for extending a water line to the west side of the rail-road tracks for a new commercial development.

Mr. Crisp reported one (1) employee's spouse tested positive for COVID-19 and was sent home last Thursday to quarantine. The employee had no direct contact with other employees.

Mr. Crisp reported on receiving a "Thank You" letter and Plaque from Edmond Electric for allowing our staff to provide Mutual Aid during the October ice storm.

Mr. Crisp reported on the electric department starting a new project at Meadow Trace that consists of replacing a direct bury three (3) phase underground electric line.

Mr. Crisp reported that Mr. Steve Powell is working on a Water System Improvements Hydraulic Analysis and Engineering Report Proposal to be presented at the next board meeting.

The Board recognized Mr. Jared Crisp (filling in for Mrs. Teri Hill) who had no Office Manager's Report.

A written Department Foreman's Report was presented with no additional comments.

Nay – none

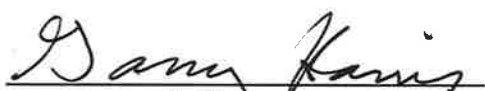
Mr. Crisp discussed and recommended the promotion of Mr. William D. Gilmore Jr. to B-Mechanic with Merit, effective December 10, 2020.
