Zoning Change for: A & R Investments

A tract of land situated in the Southwest Quarter (SW/4) of Section 9, Township 21 North, Range 19 East of the Indian Base and Meridian, Mayes County, State of Oklahoma, being more particularly described as follows, to-wit: Beginning at the Southwest Corner of said SW/4; THENCE N1°20'58"W for a distance of 880.95 feet along the West Line of said SW/4; THENCE N88°35'06"E for a distance of 836.85 feet; THENCE S1°31'40"E for a distance of 881.01 feet to a point on the South Line of said SW/4; THENCE S88°35'20"W for a distance of 839.59 feet along said South Line to the POINT OF BEGINNING. Contains 16.9525 acres, more or less. This is the West portion of this land.

The applicant is requesting the zone to be changed from Agriculture (AG) to Residential Single 70 (RS70) for residential homes. (This is the portion of land that was denied for commercial use)
