1. CALL MEETING TO ORDER.

Adam Anderson provided a written report. He stated that the 2025 Bluegrass Festival saw \$57,942.12 in unrecouped costs, \$44,212.78 higher than the 2024 festival. He also stated that they are working to improve plans for the 2026 Bluegrass Festival in hopes of lowering unrecouped costs.
