

**MINUTES
PARK BOARD
SPECIAL MEETING

THE PARK BOARD MET IN SPECIAL SESSION IN THE COUNCIL CHAMBER, 12 NORTH ROWE STREET, PRYOR, OKLAHOMA AT THE ABOVE-MENTIONED DATE AND TIME.

1. CALL MEETING TO ORDER.

Keith Shelby called the meeting to order at 5:30 p.m. Members present: Ron Reiser, Roy Jackson, Sherry Alexander, Chris Graves and Keith Shelby. Members absent: Autumn Graybill and Pamela Buffington.

Others present: Frank Powell, Dennis Bowman and Zac Doyle.

2. DISCUSS, POSSIBLY APPROVE MINUTES OF THE OCTOBER 27TH, 2025 MEETING.

Motion was made by Reiser, second by Jackson to approve the minutes of the October 27th, 2025 meeting. All voted yes.

3. PARK REPORT - SUPERINTENDENT FRANK POWELL.

a. PARKS

Powell reported that they have been working to repair the gravel washout on the paths in Centennial Park. He also stated that he expects the new play equipment at Whitaker Park to be ready for installation soon.

b. CEMETERY

Powell reported that the cemetery has remained consistently busy. He also stated that staff have recently made repairs to the eroding edge of the parking lot.

4. GOLF COURSE REPORT - DIRECTOR DENNIS BOWMAN.

Bowman reported that the Golf Course hosted 37 events in 2025. He stated that they are working on repairs to the pump station and installing a ramp that will assist with future maintenance needs.

5. DISCUSS, POSSIBLY RECOMMEND COUNCIL ACTION TO ACCEPT A BID FOR THE PURCHASE OF 60 NEW GOLF CARTS FOR THE PRYOR CREEK GOLF COURSE. BIDS RECEIVED: CLEAR CREEK GOLF CAR AND UTILITY VEHICLES IN THE AMOUNT OF \$237,345.00 AND YAMAHA GOLF-CAR COMPANY IN THE AMOUNT OF \$312,336.00.

No action taken. The Board discussed the differences between the models of carts offered and decided that the golf carts should be tested before making an informed recommendation.

6. **DISCUSS, POSSIBLY RECOMMEND COUNCIL ACTION TO ACCEPT A FINANCING OR LEASE PURCHASE QUOTE FOR 60 NEW GOLF CARTS. ONE QUOTE RECEIVED FROM BANK OF COMMERCE FOR 60 MONTHS AT A RATE OF 4.25%. TWO OTHER QUOTES WERE REQUESTED FROM FIRST PRIORITY BANK AND RCB BANK, BUT HAVE NOT BEEN RECEIVED AS OF POSTING.**
