

Minutes – PCRC Board Meeting - March 18, 2026, Mar 23, 2026, 5:30 PM

Members Present: David McFarland, Karen Cook, Ben Barnett, and Houston Brittain

Call Meeting to Order:

1. Approved February 12th, 2026, Meeting minutes: Motion by Cook, Second McFarland, approved. Petitions from the audience: None

2.. We moved to Action Items to discuss and possibly recommend Council action to appoint Vicki Corlett to the Recreation Center, Seat #1, term expiring August 31st, 2028. The seat was made vacant by the resignation of Jamie Nofsinger, effective January 9, 2026.

Discussion: Mike Moore shared that she is a member of the recreation center, active pickleball player, and walker. Houston shared that he met with Vicki and looks forward to her being on the board. Vicki shared why she would like to be on the board. She said that she believes in health, fitness, and wants to promote a healthy lifestyle. She said that she has been a member for many years and has participated in many of the land and water classes. She has been involved in the Pryor community and moved here in 1983. She was an RN for Dr. Dieker then went back to school to pursue an education degree and taught in Pryor for many years. She shared that she enjoys retired life, but wants to continue to give back to her community. Motion was made by Ben Barnett to recommend Vicki Corlett to the City Council to approve, Second made by David McFarland, all in favor for recommendation to the City Council.

3. Mike shared that the 20 Year Celebration for the Rec Center on Sunday had gone well. There were approximately 40 in attendance. Houston also shared some highlights from the celebration. Mike shared that Jackie has the Annual Egg Hunt scheduled for April 28th @ 11:00 am. It was a success last year and we are looking forward to another good hunt. The Health Fair is scheduled for June 3, 2026.

4. Director's Report:

Repairs and maintenance: First maintenance company is no longer working for the Rec Center. Mike has hired a new group that is doing a much better job. They wax two times a week(Sunday and Wednesday nights).

Mike is seeking mowing quotes for the Rec grounds.

HVAC unit is on order and should arrive in July. The price is locked in.

Mike will be putting information out for Bids in the newspaper for the men's locker rooms. This will allow us to look at the bids at the next meeting. He shared that the women's locker room would be looked into next.

Finance Report: Grounds Keeping expenses were \$1270 higher than usual due to a late fall mowing, as well as fall cleanup at the back door due to two big trees. There was an additional clean up in January. There was some discussion concerning removing the two trees and Mike was going to inquire as to whether or not the city could do that.

Mike shared that he did receive a quote of \$2400 from Shield Security for 12 new cameras to try to do a small upgrade.

Membership: 2026, 518 Cherokee, 454 walkers and 1271-day passes.

Aquatics: 18 pool parties, busy with lessons, swim teams and after school. There were also family swim times during spring break.

The Cherokee Nation has been slow to pay their portion of memberships. There was discussion about possibly asking for a flat allocation instead of month by month. Mike will be looking into this option with Danny and the Chief.

Miscellaneous: Holly bushes were removed out front and Crepe Myrtle trimmed. Fitness Challenge saw a total of just over 9 million steps!
